CUSTOMS SERVICE RELOADING: PRO et CONTRA





DESCRIPTION

The project "Support for the Public Initiative "For Fair and Transparent Customs" (the Initiative) conducts regular online surveys on various economic issues aimed at promptly receiving feedback (reactions) from interested parties on various events, initiatives of the Government, other stakeholders in customs, and related areas. The results of the relevant surveys are published and sent to the interested state authorities.

The survey **"State Customs Service reloading: pro et contra"** is an attempt to evaluate the main provisions of draft law No. 6490d dated 06.04.2023 "On amendments to the Customs Code of Ukraine regarding the establishing of specifics of service in customs authorities and certification of officials of customs authorities" (hereinafter - the draft law).

The draft law is aimed at restarting the activities of the State Customs Service of Ukraine. For example, it is proposed to introduce a transparent competitive selection of the Head of the State Customs Service by a highly qualified competitive committee created with the participation of international and foreign donors. In addition, an annual assessment of the activities of the head of customs is implemented with the participation of international and foreign donors. To strengthen his powers, it is proposed to allow personnel appointments in the customs office without the approval of the Ministry of Finance of Ukraine. An increase in the customs officers' salaries and their re-certification, is also foreseen.

These measures, according to their initiators, should contribute to increasing the stability and efficiency of the customs authorities' activities, the development of customs affairs and economic growth, and the formation of an effective basis for reducing corruption and pressure on business.

The survey is aimed at studying the expectations and attitudes of interested persons to the provisions of the draft law No. 6490-d dated 04/06/2023, aimed at restarting the State Customs Service of Ukraine.



METHODOLOGY RESPONDENTS




METHODOLOGY

The survey was conducted in an online format. Qualitative and quantitative approaches were used for data collection.

The field stage was held from July 24 to August 11, 2023.

RESPONDENTS

104 respondents from 20 regions of Ukraine took part in the online survey (Vinnytsya, Dnipropetrovsk, Donetsk, Zhytomyr, Zakarpattya, Zaporizhzhya, Ivano-Frankivsk, Kyiv, Lviv, Mykolaiv, Odesa, Poltava, Rivne, Sumy, Ternopil, Kharkiv, Khmelnytskyy, Cherkasy, Chernivtsi, Chernihiv) and Kyiv city.






Assessment of provisions aimed at reloading customs







RESPONDENTS' COMMENTS



RESPONDENTS' COMMENTS

- 1. A large number of respondents' comments indicate the relevance of the issue of "customs reload"
- 2. A significant number of comments refer to the re-certification of customs officials and indicate a negative attitude of customs officials to such proposals
- 3. In the comments, respondents support measures to "reload customs" but do not expect quick changes

4. A significant number of comments support the restoration of wealth declaration



SOME COMMENTS FROM RESPONDENTS

Regarding the election of heads of state authorities by representatives of international organizations:

- "The experience of the competitive election of heads of executive service bodies with the participation of international organizations did not increase the efficiency of the work of such bodies. The election of one manager according to any procedure without the possibility of forming the authority from competent people does not provide an opportunity to carry out qualitative changes"
- "In my opinion, representatives of public organizations of Ukraine, not only foreign ones, should also be involved in the control. Although their presence is certainly important"

Regarding certification of customs workers

- "Conducting annual/periodic attestation does not provide an assessment of the level of competence of workers (everyone always passes attestation)"
- "I am a customs officer. I've already been through all the circles of certification, re-certification, and training hell. Where else can I re-certify? In the draft law, it should be noted that citizens who enter the customs service for the first time or who have not worked at the customs for a long time pass such attestations. Why do you go through everything again if you have already gone through it? The team of customs workers who passed such a procedure should not face exams again under the banner of another law. It creates tension in the team and leads to understandable indignation. I express the opinion of many people"
- "How much can you mock the customs officers. There was already a reboot in 2021!"
- "Attestation is ineffective given the low salary level of customs officers; people currently lack motivation. A competitive salary
 increase is only promised from year to year, but the certification of knowledge of the law and integrity was already passed a
 couple of years ago, and where is the salary increase for ordinary inspectors??? There are people who got nervous during
 these tests, and an ambulance was called for them for people of pre-retirement age, this is generally bullying."



SOME COMMENTS FROM RESPONDENTS

Regarding the fight against corruption:

- "Restoration of declaration will help reduce corruption at customs"
- "To overcome corruption in customs, it is necessary to introduce a legally established algorithm of responsibility of officials in case of committing illegal actions and making illegal decisions. This responsibility should occur automatically and not depend on the decision of the management of the customs authority."
- "It is necessary to submit property declarations for the heads of customs authorities before receiving a position, and then to prove the origin of all assets; this also applies to relatives (and not only close relatives, but all of them)"

Regarding "customs reload":

- "I consider it advisable to completely reboot cuatoms"
- "First of all, it is necessary to significantly improve the working conditions and determine the responsibility for the implementation of the current legal acts by the workers of the State Migration Service of Ukraine. At the same time, the personnel composition of customs bodies should be changed based on the results of practical work. A total reboot will have a negative result"
- "For the "reboot" to be successful, it must be accompanied by a radical reduction of the discretion of customs officials (in particular, but not only, in the matter of determining the customs value) and an equally radical increase in transparency with independent external control of the work of customs posts through means of video surveillance, duplication of all documentation, and images from scanners in real-time. All cargo for which there is no information from the customs authorities of the country of origin must be scanned. The advantages provided by the status of AEO should be minimized. Instead, a simplified procedure should be applied to imports from countries that provide customs information in the framework of the exchange"



CONCLUSIONS



- 1. The vast majority of respondents supported all proposals aimed at reloading the State Customs Service of Ukraine, set out in the draft law
- 2. The proposal to conduct an annual external independent assessment of the effectiveness of the Head of the State Customs Service work gathered the greatest support from the respondents 89%
- 3. A significant number of respondents (70%) supported the participation of representatives of international and foreign organizations in the annual external independent assessment of the effectiveness of the Head of the State Customs Service work
- 4. 67% of respondents supported the proposal regarding the impossibility of holding the position of Head of the State Customs Service by one person for more than two terms in a row
- 5. 63% of respondents supported the appointment and dismissal of the heads of the structural divisions of the State Customs Service without the approval of the Ministry of Finance of Ukraine



CONCLUSIONS


- 6. 65% of respondents believe that representatives of international and foreign organizations should play a key role in the selection of candidates for the position of the head
- 7. 65% of respondents supported the need to conduct attestation of customs authorities' officials in to confirm the appropriate level of qualification
- 8. Despite the significant support for all the innovations of the draft law, the statement that the adoption and implementation of its norms will increase the stability and efficiency of customs work and reduce the level of corruption was supported by only 54% of respondents, which is less than the support for individual norms of the draft law


The vast majority of respondents supports the measures of the draft law and spoke FOR the reload of the State Customs Service of Ukraine
